

**VERIBEST INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES
JOINT ELECTION RESOLUTION
TOM GREEN COUNTY, TEXAS**

WHEREAS, Chapter 31, Subchapter D, of the Texas Election Code authorizes the governing body of a political subdivision to contract with the County's election officer for election services in an election ordered by the political subdivision; and

WHEREAS, Texas Education Code §11.0581 requires that the District conduct its election on the same date as the election for members of the governing body of a municipality located in the school district and jointly with that municipality;

WHEREAS, Chapter 271 of the Texas Election Code provides for joint elections when an election is required upon the same day by two or more political subdivisions occupying all or a part of the same county; and

WHEREAS, the Veribest Independent School District desires to contract with the Tom Green County election officer for election services for its May 4, 2024, General Trustee and Special Trustee election and for any other special or bond elections that may be called by the District during the term of the contract; and

WHEREAS, several other political subdivisions within Tom Green County also are conducting elections on the same day and are also contracting with the Tom Green County election official for election services; and

WHEREAS, the Veribest Independent School District desires to conduct a joint election on May 4, 2024, with the City of San Angelo and all other such governmental units as are eligible and desire to conduct a joint election with the City of San Angelo as may be expressed by order, resolution, or other official action of said governmental units;

NOW THEREFORE BE IT RESOLVED BY THE VERIBEST INDEPENDENT SCHOOL DISTRICT:

THAT the Veribest ISD Board of Trustees hereby authorizes and directs the Superintendent or School Board President to execute the attached Joint Election Contract with Tom Green County for the May 4, 2024, General Trustee and Special Trustee election and for any other special or bond elections that may be called by the District during the term of this contract; and

THAT the said Joint Election Contract shall be deemed a joint election agreement authorized by this Resolution with the City of San Angelo and any other governmental units within Tom Green County that are conducting an election on May 4, 2024, and that desire and are eligible to conduct a joint election with Veribest ISD through their contracts with Tom Green County; and

THAT the Veribest ISD Board of Trustees hereby appoints Vona Hudson as the early voting clerk for the election; and

THAT the Superintendent is hereby authorized and directed to make any necessary changes to the Election Order exhibits or otherwise to take any and all actions as may be necessary to carry out the purposes of this Resolution.
