We recently completed our review of your office's financial records for the months of January through March of 2015.

As part of our work, we reviewed a sample of fees from the receipt journal report to ensure the fee amounts appeared appropriate compared to the Justice Courts schedule of fees. We found two cases regarding issuance of bad checks that did not include court costs. If a plea of guilty or nolo contendere is entered in the judgment, we recommend the court costs be assessed since these are payable to the State.

Included in the review were the Treasurer's receipts, Justice of the Peace receipts, Justice of the Peace/Treasurer deposit reports, receipt journals by fund and fee code, receipt journal report, and the Official Justice of the Peace monthly report. We appreciate your cooperation and willingness to help provide the documentation needed to perform this review. If you have any questions or concerns, feel free to contact us.

In our review of the financial activity of your office during the period of October 1, 2014 through December 31, 2014, we found that the County's bank accounts at Wells Fargo were under collateralized two times. The largest instance was on October 30th, when county funds were under collateralized by \$621,020.79. While these instances were not lengthy, proper collateral for the County's deposits should be maintained at all times. Both times the issue was resolved by the bank pledging additional collateral to cover the deposits within a few days, and we do note that you have been in frequent contact with them about it. We recommend that you continue to monitor the collateral and take proactive measures when known large deposits are expected, so that the depository can make appropriate pledges in time.

Also, we found a land lease payment that was due to the County on January 1st but was not paid until February 9th. There were also payments due from the Library space lease on January 3rd and February 3rd, both of which were not received until February 13th. While you are not at fault for late payments, we recommend that you monitor the payment due dates and contact the lessees when they do not meet deadlines.

There were a few other minor findings that we have discussed with you separately, but do not represent a major impact to our review. We appreciate your cooperation during the review, and ask that you contact our office if you have any questions.
