We have completed our review of your office's financial records for the period of April 2022 through June 2022. Included in the review were internal controls, revenues, accounts payable to include quarterly payments to the state, cash and near cash balances, securities, bank reconciliations, collateralization, payroll, 941 payroll tax reports, TCDRS deposits, docks, paid time off accruals, outstanding debt, unclaimed property, investment reports, interest earned, and your continuing education hours.

In our review of payroll accruals, the number of errors for the quarter did increase from 14 to 31. This is still a relatively small number representing a low error rate. However, 23 of the findings were for sick and comp time accruals, and there was a delay of over two months in correcting the balances after we notified you of the errors. We recommend correcting accrual errors upon notification, or setting aside a specific time to address the issues found. Left uncorrected for extended times, this can directly impact the employees' requests for sick time or pay-outs of comp upon separation.

We discussed with you separately a few other minor errors we found during the review. We appreciate your cooperation and willingness to help provide the information we needed to perform this review. If you should have any questions, please do not hesitate to contact me.

We recently completed our review of your office's financial records for the months of April 2022 through September 2022. Included in the review were the Treasurer's receipts and deposit reports for your office, Justice of the Peace, Precinct 2 receipts, receipt journals by fund and fee code, till balance reports, Citations Count Report, scanned citations and warrants, and the Official Justice of the Peace Precinct 2 monthly reports. The review included fee collections and cash receipts from iCON (Net Data).

While reviewing your department's paid warrants, we discovered one case still had a warrant outstanding in Odyssey and iCON six months after it was paid in full. Your staff recalled the active warrant as soon as we notified them of the matter. We recommend that you continue to run the warrant procedures on a weekly basis to ensure all warrants are recalled in a timely manner.

We have completed our review of your office's financial records from October 1, 2021 to September 30, 2022. Our review included an examination of the receipts issued, fees collected, applications made through the TCEQ, and disbursements to the State.

As the fees charged for Environmental Health Services haven't changed for nearly 22 years, we suggested evaluating the fee amounts and adjusting them, if needed. When presenting the updated fee schedule to Commissioner's Court, we highly recommend delineating the charges for each type of septic tank permit: single, multiple and re-inspections; and including a statement that the fees charged for new septic tank permits include the \$10.00 Texas Commission on Environmental Quality (TCEQ) fee.

Overall, we found your financial records to be in order. We appreciate your effort to turn-in your revenue on a timely basis and your cooperation during the review. If you have any questions or concerns, please contact my office.
