**MINUTES**

The Tom Green County Bail Bond Board met on Wednesday, August 19, 2020 via the Zoom Meeting online platform at 11:00AM.

Board Chair Dianna Spieker called the meeting to order at 11:00AM and Board Secretary Louie Perez called for an audio roll call and then acknowledged that a quorum was present.

Item Number 2 was any Public Comment. There were none at this time.

Under Item Number 3, Consent Agenda, the minutes from the last meeting, July 22, 2020, were presented by Dianna Spieker. Under the Consent Agenda, Item 2(b), the Bond Surety Balance Report was emailed to the Board previously. Christina Ubando made a motion to approve the items under the Consent Agenda as presented. Judge Weatherby seconded the motion. A vote was taken and the motion carried.

Item Number 4 was any submitted Bail Bond Applications within the 30 day window. There were none at this time.

Item Number 5 consisted of an update on the Zapata Bail Bonds Final Judgment. To date, the case is moving forward according to the attorney's that are handling the issue.

Item Number 6 was to consider Clear Choice Bail Bonds request to place 25 W. 8<sup>th</sup> Street, legal description as: Lot 7, Block 23, Miles Addition, San Angelo, Texas Tom Green County as collateral with the Bail Bond Board. The appraisal value of the property was listed at \$82,530.00 and all the criteria to place said parcel has been met in accordance with the rules. Christina Ubando made a motion to approve the listed property. Anthony made a seconded to the motion. A vote was taken and the motion passed.

Item Number 7 was a briefing from the bail bond companies. There was nothing to report at this time.

Item Number 8 was Future Agenda items. Louie Perez asked the Chair to add to the next agenda the letter sent by the Texas Attorney General to Texas County Treasurers in reference to the collection of Bail Bond Forfeiture Fees.

Item Number 9 was Announcements. The next tentative meeting is scheduled for September 16, 2020 but will be waived and the next Regular Meeting will be on October 21, 2020.

Item Number 10 was Adjournment. Dianna Spieker adjourned the meeting at 11:09 AM.
