

The Tom Green County Bail Bond Board met on Wednesday, January 20, 2021 via the Zoom Meeting online platform Meeting ID: 837 5022 3763 at 11:00AM.

Board Chair Dianna Spieker called the meeting to order at 11:10AM and Board Secretary Louie Perez called for an audio roll call and then acknowledged that a quorum was present.

Item Number 2 was the Consent Agenda. The items consisted of the Minutes from the last meeting, December 16, 2020, the Bond Issuance Monthly Report, Record the Sheriff Designee, Record Open Meeting and Public Information Act Certificates from Designees, and accept and record as a matter of record the Fiscal Year 2020 Revenue and Expense Report. The Fiscal Year 2020 Revenue and Expense Report was tabled until the next meeting. Chief Deputy Roger Looka was appointed as the Sheriff's Designee and the certificates for all the appointed Designees were recorded. 





The Tom Green County Bail Bond Board met on Wednesday, July 21, 2021 via the Zoom Meeting online platform Meeting ID: 881 4921 3363 at 11:00AM Central Time.

Board Chair Dianna Spieker called the meeting to order at 11:10AM and Board Secretary Louie Perez called for an audio roll call and then acknowledged that a quorum was present.

Item Number 2 was the Consent Agenda. The two items consisted of the Minutes from the last meeting, April 14, 2021, and the Bond Issuance Monthly Report. Anthony Monico made a motion to approve the items under the Consent Agenda as presented. Christina Ubando seconded the motion. A vote was taken and the motion carried.

Item Number 3 was any submitted Bail Bond Applications within the 30-day window. Alliance Bail Bonds was on the agenda for renewal. The application was presented for approval. Eddie Howard made a motion to accept as presented. Anthony Monico seconded the motion. The motion passed.

The other application was Freedom Bail Bonds II. This is a new application in which the current license for Freedom Bail Bonds would be surrendered upon approval of the current pending application. This request is being made by the current Insurance Company in which Ricky Villarreal is the licensed agent. Thus, the current insurance company is International Fidelity Insurance Corporation and the new license would be under Allegheny Casualty Company. The current, active license would need to be surrendered and all authority and bail bonds would fall under the new insurance company, i.e., surety powers. A motion was made to approve the application by Roger Looka and the motion was seconded by Todd Allen. Judge Weatherby abstained from the vote. The motion passed.

Ken Good who was in the audience and a member of the Legislative Committee for the Professional Bail Bondsmen of Texas gave an update on the legislative issues pertaining to bail that were addressed in the 87<sup>th</sup> legislative session. House Bill 2 and Senate Bill 8 were discussed at length by Ken Good. House Bill 1005 of the Occupations Code was presented and it was determined that this bill does not require any action by the bail bond board. In conclusion, the Texas Legislature is currently in Special Session. An update will follow with regards to what bills passed and the outcomes of the Special Session with regards to bail bond issues and any items that might affect the bail bond board.

Item Number 8 was to consider zoom meetings transition from Zoom to In Person. In person meetings or zoom meetings was the issue at hand. The majority of the members suggested staying with zoom meetings for the time being.
