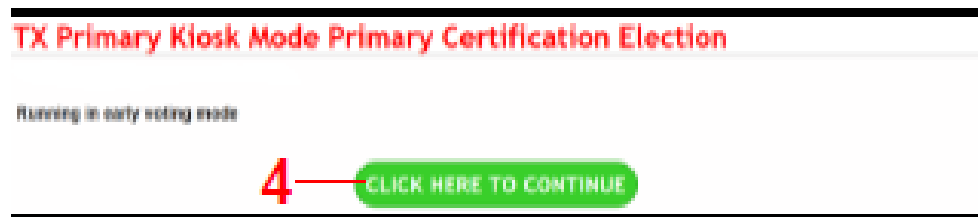
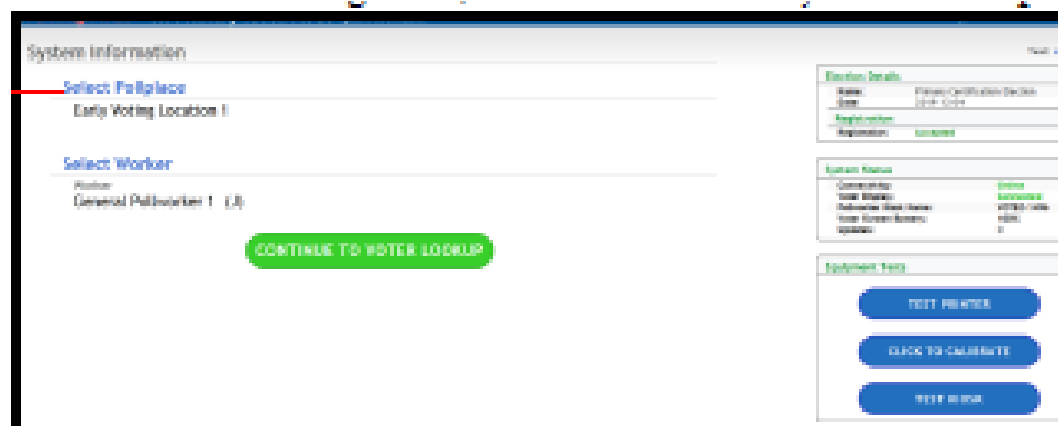


With the new system, you do not have to ask the voter questions any longer. The screen will display the options and information for confirmation which relieves the poll worker from asking.

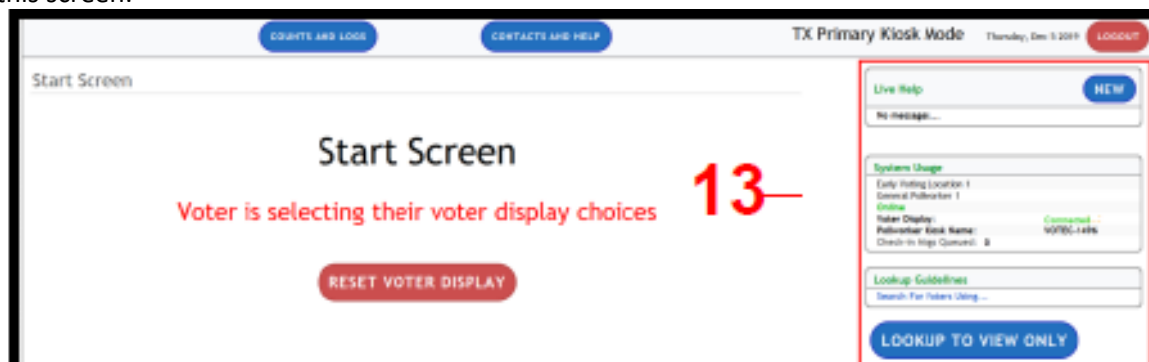
Kiosk will start the same way it was. You will need to turn your data gizzard on and get WiFi connected, then you will need to turn the VPN on (globe on the bottom right-hand side of the laptop). You will see this new screen:



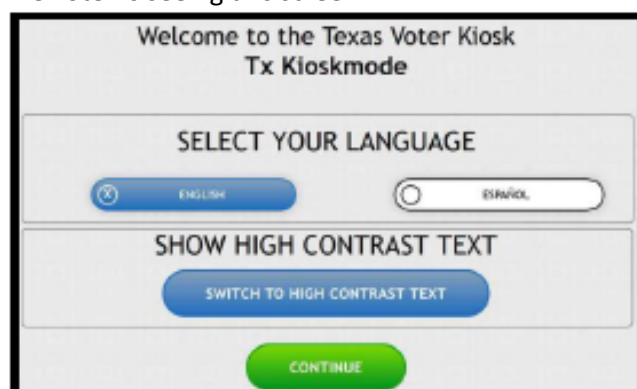
This is where you will stop to turn the tablet on.



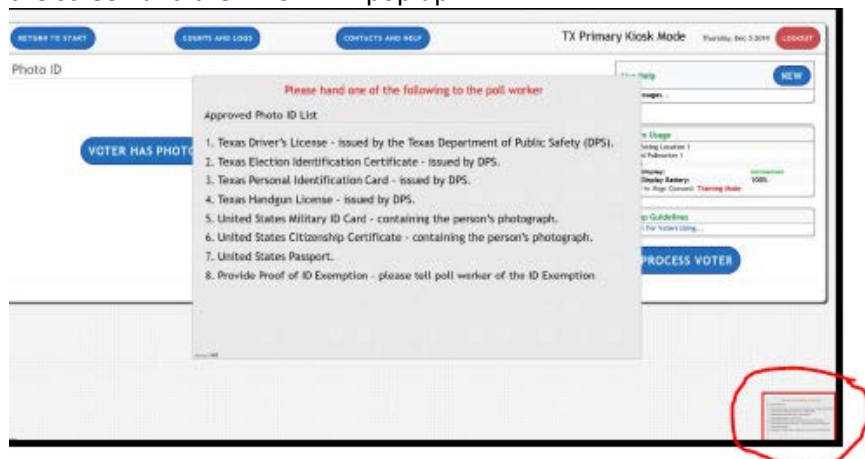
Don't forget to test printer and kiosk. Once you have clicked on "continue to voter lookup" you will see this screen:



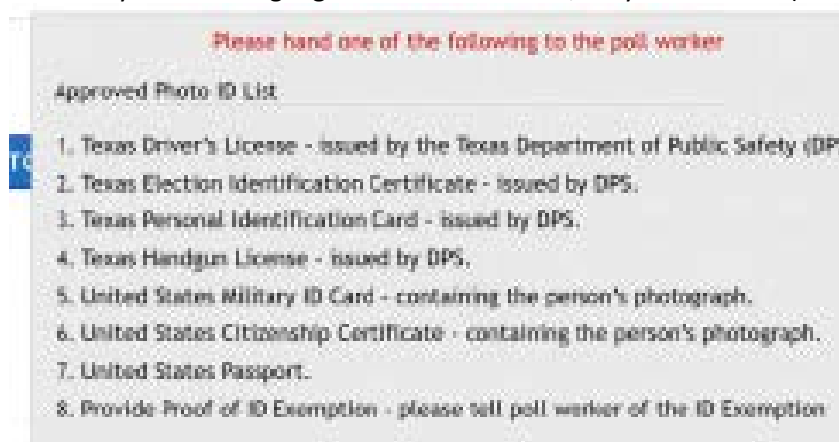
The voter is seeing this screen:



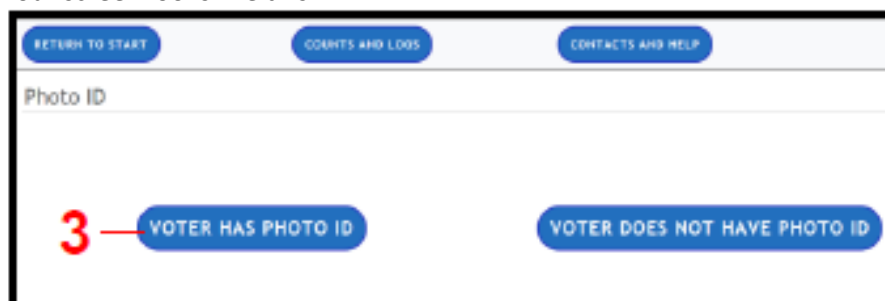
Any time you want to see what the voter is seeing, you can point the mouse to the bottom right-hand of the screen and their view will pop up.



Once they touch a language and then Continue, they will see this (List A photo ID) screen:



Your screen looks like this:

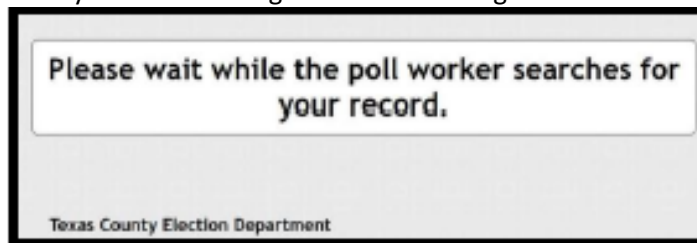


If the voter hands you a List A ID, you will click on "voter has photo ID."

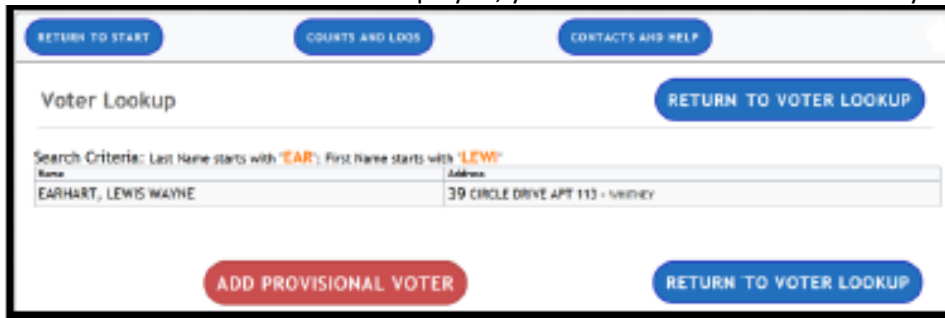
You will now look up the voter. Except for the buttons at the top, this screen looks and works like it did before.

Once the list of voter's names is displayed, you will select the correct voter by clicking on the name.



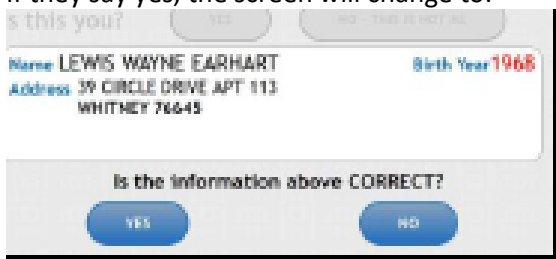
You now see this screen:

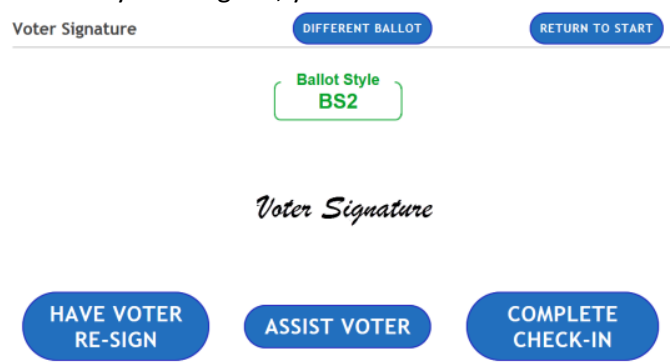

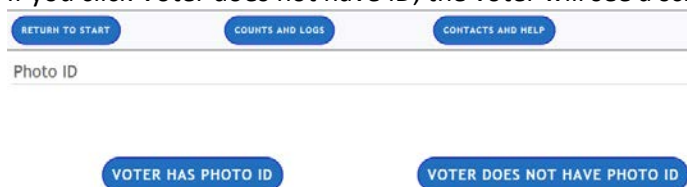

**\*VOTER'S SIMILAR NAME AFFIDAVIT:** If it is determined that the name on the form of identification provided under § 63.0101 is substantially similar per § 63.001(c), and by initialing the square labeled "Similar Name Affidavit," I swear or affirm I am the person on the list of registered voters or the person on the voter registration certificate, and I am one and the same as the person named on the identification provided.
