

# Notice About 2021 Tax Rates

(current year)

Property Tax Rates in Tom Green County

This notice concerns the 2021 property tax rates for Tom Green County.

This notice provides information about two tax rates used in adopting the current tax year’s tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

**This year’s no-new-revenue tax rate** . . . . . \$ .53231/\$100  
**This year’s voter-approval tax rate** . . . . . \$ .55344/\$100

## Unencumbered Fund Balances

**Voter-Approval Tax Rate Adjustments**

**State Criminal Justice Mandate**

The Tom Green County Auditor certifies that Tom Green County has spent \$578,337.13 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. The Tom Green County Sheriff has provided Tom Green County information on these costs, minus the state revenues received for the reimbursement of such costs. This increased the voter-approval tax rate by \$.00083/\$100.
