### Tom Green County Commissioners' Court Special Meeting –September 30, 2003

The Tom Green County Commissioners' Court met in a Special Session in the Commissioners' Court Room of the Edd B. Keyes Building Wednesday September 30, 2003 with the following present:

Karl Bookter, Commissioner Precinct #2
Jodie R. Weeks, Commissioner Precinct #3
Richard Easingwood, Commissioner Precinct #4
Michael D. Brown, County Judge

- 1. Judge Brown called the meeting to order at 2:12 P.M.
- 2. Judge Brown moved to adopt the Resolution of Tom Green County authorizing designated signatories for Texas Community Development Program Contract No. 723165. Commissioner Weeks seconded the motion and all voted in favor. (Recorded with these minutes.) Judge Brown explained that this is a Colonia Planning Grant in the amount of \$130,000.00.
- **3.** The people who submitted resumes and expressed an interest in being appointed to fill the vacated Constable #3 position were James Smith, Tommy Sykes, Roy Balderas, Lou Hargraves. Judge Brown explained that this Constable's position has in the past, also worked with the mental health deputy unit. Mr. Smith and Mr. Sykes were available for presentations and questions.

**Judge Brown recessed the regular meeting** of the Commissioners' Court to go into Closed/Executive Session in accordance with V.T.C.A. Government Code, Chapter 551 and Subchapter D at 2:31 P.M.

**Judge Brown reconvened** the regular meeting of the Commissioners' Court at 2:46 P M

Commissioner Bookter moved to appoint James Smith to fill the unexpired term of Constable Precinct #3 at the present FY 2003 – 2004 Budgeted amount of salary. Commissioner Weeks seconded the motion and all voted in favor.

The Commissioners thanked all the applicants and expressed their pride in the amount of experience and qualifications of each applicant.

4. Judge Brown moved to amend the policy concerning "Base pay for newly Elected Officials" that was approved July 23, 2003 in the Commissioners' Court Budget meeting to read "Base pay for newly Elected Officials or newly appointed Officials". Commissioner Friend seconded the motion. Judge Brown amended his motion from "Base pay for newly Elected Officials or newly appointed Officials" to add a phrase "Base pay for newly Elected Officials or newly appointed to an elected position" to be effective October 1st, 2003. Commissioner Friend seconded the amended motion and all voted in favor. (The following fees were adopted):

**5.** Sheriff Hunt explained to the Court that they had been unable to employ an additional nurse to fill the current vacancy. He requested that paramedics, either licensed or certified, to fill the vacancy on a rotating basis that will be selected from a pool. He also requested the use of medical assistants or medical aids under the direction of Dr. Mendoza. The medical personnel, under this request, will be hired on a stand by basis. He requested the salaries of \$12.00 and \$9.00 per hour according to the qualifications.

Judge Brown moved to allow the Sheriff to utilize licensed or certified Paramedics as Jail Medical Assistants I, to be paid \$12.00 per hour and medication aids or medical assistants as Jail Medical Assistants II to be paid \$9.00 an hour to fill the position of jail nurse when vacancy arises and work under the authority of the Jail Physician. Commissioner Weeks seconded the motion and all voted in favor. Commissioner Easingwood asked Milly Wilson, Personnel Director, to prepare the job descriptions for review to assure the proper wording of the requirements.

- 6. Commissioner Friend request item 6 regarding the appointment of a County Agent for Tom Green County be passed until September 14, 2003 awaiting approval from A&M. **No action taken.**
- 9. Judge Brown moved to adopt the Memorandum of Understanding (MOU), dated October 1, 2003, between the Texas Department of Criminal Justice Institutional Division (TDCJ-ID) and Tom Green County as presented and as part of that MOU to also approve Amendment # 5 between ARAMARK Correctional Services, Inc. and Tom Green County for the TDCJ –ID San Angelo work camp, located at Carlsbad. Commissioner Easingwood seconded the motion and all voted in favor. (Recorded with these minutes.)
- 8. Commissioner Weeks moved to accept the Treasurer's Monthly Report for August 2003 as presented. Commissioner Friend seconded the motion and all voted in favor. (Recorded with these minutes.)
- 7. A lengthy discussion was held regarding the adoption of changes to the current Personnel Policy. There was some discussion regarding the non-requirements of morning and afternoon breaks and that only 30-minute lunch hours were required. The overtime and comp time issue continued to be the major issue of disagreement. There were some alternative policies discussed. **No action was taken.**
- 10. Judge Brown moved to authorize the issuance of incentive vouchers for ½ day of administrative leave for each fair share giver and 1 day of administrative leave for double fair share givers to the United Way of the Concho Valley. Commissioner Friend seconded the motion. Judge Brown and Commissioners Friend, Bookter and Weeks voted in favor. Commissioner Easingwood voted in opposition. The motion passed 4 to 1.
- 11. There were no line item transfers.
- 12. Future Agenda Items:
  - 1. Consider appointment of Extension Agent.
- 13. Announcements:
  - 1. Judge Brown officially swore in Fred Buck, Justice of the Peace for Precinct #3, prior to the beginning of the meeting. Mrs. Buck was also present while the oath was taken.
  - 2. There will be an Emergency Management Exercise this week.
  - 3. There will be a discussion regarding personnel policy changes with department heads or their representatives Friday, October 3, 2003 in the Commissioners' Courtroom at 1:30 P.M.
  - 4. There will be a Trail Ride from Sonora with a stop over in Pugh Park in connection with the Stock Show and Rodeo on February 19<sup>th</sup>, 2004.

The Special Meeting was adjourned at 4:35 P.M.

#### MEMORANDUM OF UNDERSTANDING October 1, 2003

THIS MEMORANDUM OF UNDERSTANDING between the Texas Department of Criminal Justice - Institutional Division (TDCJ-ID) and Tom Green County, Texas, a political subdivision of the State of Texas, with its general offices located at 122 West Harris, San Angelo, Texas 76903 (COUNTY) is developed to define and formalize commitments made by each entity for the work program within Tom Green County which shall utilize offender labor services assigned to the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3).

- 1. TDCJ-ID shall provide offender labor services to COUNTY and other participating governmental entities as approved by TDCJ-ID to assist with accomplishing proposed work projects within Tom Green County. The public work projects shall be within Tom Green County, Texas and surrounding counties. The public work projects shall be approved by COUNTY and submitted to TDCJ-ID by COUNTY and the participating governmental entities for approval by TDCJ-ID.
- 2. The public work projects designated include but are not limited to general cleaning, maintenance, and land clearing. The offender labor service required for the accomplishment of the public work projects will be provided by TDCJ-ID.
- 3. TDCJ-ID shall provide and be responsible for the supervision, security, housing, medical and other services for the offenders care and confinement at San Angelo Work Camp (W3).
- 4. TDCJ-ID shall be provide and be responsible for the housing of offenders and accordingly shall be responsible for the cost of utilities associated with such housing.
- 5. TDCJ-ID shall provide transportation to the public work projects and shall maintain all motor vehicles and motorized equipment to be used for the transportation of offenders to the work projects. The motor vehicles and motorized equipment shall be maintained by TDCJ-ID in a safe condition and operated in a safe manner.
- 6. COUNTY shall provide laundry and food services for the offenders assigned to the Texas Department of Criminal Justice Institutional Division San Angelo Work Camp (W3).
- 7. COUNTY's obligations are as follows:
  - A. COUNTY shall provide wholesome and nutritious meals (3800 calorie menu) for the offenders assigned to the Texas Department of Criminal Justice Institutional Division San Angelo Work Camp (W3). The population of the offenders shall not exceed 40.

- B. COUNTY shall provide up to 40 meals for the offenders (actual meal count each day to be coordinated between COUNTY or its designated representatives and TDCJ-ID), three times per day, seven days per week. COUNTY shall provide:
  - one hot breakfast, one prepared sack lunch (minimum of 800 calories, excluding beverage and dessert) and one hot dinner per offender Monday through Friday with the exception of observed State holidays (see Exhibit A - Observed State Holidays); and
  - ii. one hot breakfast, one hot lunch and one hot dinner per offender during Saturday, Sunday and observed State holidays identified in Exhibit A attached hereto.
- C. Each meal shall include a beverage. COUNTY shall provide adequate portions of each item for each meal in either insulated transport carriers or prepared sack lunches, unless otherwise specified. Each lunch shall be completely prepared and sacked by COUNTY prior to pick up by TDCJ-ID. Insulated transport carriers will be provided by COUNTY.
- D. COUNTY shall, on a monthly basis, provide TDCJ-ID with a copy of the menu from the prior month. COUNTY shall assure that the menus, to include dietary allowance, are approved at least annually by a qualified nutritionist or dietitian to ensure that the menus meet the nationally recommended dietary allowances for basic nutrition.
- E. COUNTY shall provide laundry service for the offenders.
- 8. TDCJ-ID's Obligations are as follows:
  - A. TDCJ-ID agrees to notify COUNTY at least 24 hours in advance of changes in meal types, such as from sack lunch to hot meal. Any permanent increase in the population of offenders will be reflected in a written contract modification.
  - B. TDCJ-ID will provide plates and cups.
  - C. TDCJ-ID shall rinse insulated trays and/or transport containers prior to their return to COUNTY.
  - D. At a mutually agreed time, TDCJ-ID will pick up the food and beverages from COUNTY food service prior to each meal. At a mutually agreed time, TDCJ-ID will return the food and beverage containers to COUNTY food service after the completion of each meal.

- E. If TDCJ-ID finds any spoiled or unwholesome meals, TDCJ-ID will return the allegedly spoiled and unwholesome food and beverages to the Food Service Manager for the COUNTY.
- F. TDCJ-ID will serve the meals to offenders.
- G. TDCJ-ID will submit to COUNTY weekly the number of meals served to the offenders assigned to the Texas Department of Criminal Justice Institutional Division San Angelo Work Camp (W3) for the previous week (seven days). The specific day of the week the meal count will be submitted to the COUNTY will be established by mutual agreement of the parties.
- H. TDCJ-ID will monitor COUNTY food service operations by periodic on-site inspections. TDCJ-ID will perform inspections in a manner that will not unduly interfere with COUNTY's performance of services. COUNTY shall furnish all reasonable facilities and assistance for the safe and convenient performance of these inspections.
- 9. This Memorandum of Understanding is to begin October 1, 2003 and shall terminate on September 30, 2004, unless terminated sooner in accordance with this Memorandum of Understanding.
- 10. COUNTY is associated with TDCJ-ID only for the purposes and to the extent set forth herein, and with respect to the performances of services hereunder. Nothing contained herein shall be deemed or construed to create a partnership or a joint venture, to create the relationship of an employer-employee or principal-agent, or to otherwise create any liability for the parties with respect to the indebtedness, liabilities and obligations of the other party.
- 11. Either party may terminate this Memorandum of Understanding, without cause, upon thirty (30) days prior written notice to the other party.
- 12. This Memorandum of Understanding may be amended or supplemented only by a written document signed by the duly authorized representatives of COUNTY and TDCJ-ID.
- 13. This Memorandum of Understanding shall be governed by and construed in accordance with the laws of the State of Texas. Venue shall be in San Angelo, Tom Green County, Texas.
- 14. This Memorandum of Understanding and any written modifications constitute the sole agreement between COUNTY and TDCJ-ID. Any oral agreements or understandings outside the terms of this Memorandum of Understanding shall be void and have no force and effect.

## EXHIBIT A

#### Amendment No. 5 to Food Service Contract for Tom Green County Detention Facility

THIS AMENDMENT, hereinafter referred to as AMENDMENT, by and between Tom Green County, Texas, a political subdivision of the State of Texas, with its general offices located at 122 West Harris, San Angelo, Texas 76903 (hereinafter referred to as "COUNTY") and ARAMARK Correctional Services, Inc., a Delaware corporation, with offices at 1801 South Meyers Road, Oakbrook Terrace, Illinois 60181 (hereinafter referred to as "ARAMARK") is entered into to be effective the 1st day of October, 2003.

#### WITNESSETH

WHEREAS, Tom Green County, Texas, a political subdivision of the State of Texas, and Correctional Foodservice Management entered into a food service contract for Tom Green County Detention Facility dated February 23, 1999, for food service at the Tom Green County Detention Facility, and subsequently such contractual agreement was, with the consent of the COUNTY, assigned by Correctional Food Service Management to ARAMARK;

WHEREAS, COUNTY has entered into a Memorandum of Understanding effective October 1, 2003 with the Texas Department of Criminal Justice - Institutional Division to provide food services for the offenders assigned to the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3).

WHEREAS, COUNTY desires to amend its Food Service Contract with ARAMARK to provide the food services to the offenders assigned to the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3) and ARAMARK desires to provide the food service to these offenders; and

WHEREAS, the parties desire to amend said contractual agreement as hereinafter set forth effective October 1, 2003;

NOW, THEREFORE, for and in consideration of the mutual covenants, obligations, benefits, and agreements herein contained, the COUNTY and ARAMARK do hereby agree as follows:

- ARAMARK shall provide wholesome and nutritious meals (3800 calorie menu) for the offenders assigned to the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3).
- ARAMARK shall provide meals for the offenders (actual meal count to be coordinated with designated representatives of the Texas Department of Criminal Justice - Institutional Division), three times per day, seven days per week.
- 3. ARAMARK shall provide one hot breakfast, one prepared sack lunch (minimum 800 calories, excluding beverage and dessert) and one hot dinner per offender Monday through Friday with the exception of Observed State Holidays (see Exhibit A Observed State Holidays).

- 4. ARAMARK shall provide one hot breakfast, one hot lunch, and one hot dinner per offender during Saturday, Sunday, and Observed State Holidays identified in Exhibit A attached hereto.
- 5. ARAMARK shall include a beverage with each meal.
- 6. ARAMARK shall provide each meal in either an insulated transport carriers or prepared sack lunches. The sack lunches shall be completely prepared and sacked by ARAMARK prior to pick up by Texas Department of Criminal Justice -Institutional Division.
- 7. ARAMARK shall, on a monthly basis, provide COUNTY with a copy of the menu from the prior month. ARAMARK shall assure the menus, to include dietary allowance are approved as least annually by a qualified nutritionist or dietician to ensure that the menus meet the nationally recommended dietary allowances for basic nutrition.
- 8. ARAMARK shall ensure the meals and beverages are available for Texas Department of Criminal Justice Institutional Division at such times as determined by Texas Department of Criminal Justice Institutional Division.
- 9. ARAMARK will allow Texas Department of Criminal Justice Institutional Division to monitor the food services operations on a periodic on-site basis which shall include inspections of the premises. ARAMARK shall ensure that the facilities are made available for inspection by Texas Department of Criminal Justice Institutional Division.

ARAMARK has agreed to provide to the COUNTY the food services to the offenders at the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3) pursuant to the following price scale:

26 - 50	\$2.16
51 - 75	\$1.905
76 - 100	\$1.835
100 - 125	\$1.767

ARAMARK shall submit to COUNTY on a weekly basis an invoice (application for payment) for the actual meals provided to the offenders assigned to the Texas Department of Criminal Justice - Institutional Division - San Angelo Work Camp (W3). This invoice shall identify the number of meals provided to the offenders on a daily basis. The price per meal shall be those amounts as set forth above. The invoice (application for payment) shall be submitted to the Treasurer for Tom Green County at the address reflected below:

On receipt of the invoice from ARAMARK the Treasurer will verify the number of meals by and through an authorized representative of Texas Department of Criminal Justice. The Treasurer upon the reconciliation of the invoice and the verification by Texas Department of Criminal Justice will submit the invoice to the Tom Green County Commissioners Court for its consideration and approval.

Either party to this Amendment may unilaterally terminate this Amendment upon thirty (30) days written notice.

Except as hereinabove provided, said Food Service Contract is hereby in all respects ratified and confirmed.

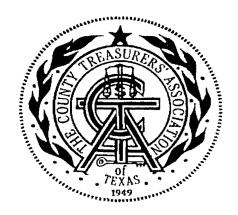

## **Yields Rise as Economy Shows Improvement**

Favorable economic data continues to roll in as momentum builds for a stronger end to the year. Rising corporate profits, continued strength in consumer spending, a rise in capital spending by businesses and low inflation are some of the encouraging signs leading the stock market up and the bond market down.

The unemployment rate is still hovering around 6 percent and this has kept investors wondering whether this economic recovery can be sustained without job growth.

Currently, the market is anticipating that the Federal Open Market Committee (FOMC) will raise interest rates by the end of the first quarter 2004. Fed Fund Futures are pricing in 50 basis points of tightening by the end of next June. Interest rates have risen much faster than most economists had expected, since the Fed has stated it is in no hurry to raise interest rates until the inflation rate rises. The market may be getting ahead of itself, but investors fear that once the Fed starts raising rates

they may do so aggressively – possibly by 50-75 basis points at a time. Although higher rates will be good news for money market investors, we may have to wait a little longer than currently thought.

The FOMC will meet again on September 16, 2003. Economic statistics to watch in September are: ISM (formerly NAPM – 9/2), the employment situation (9/5), Retail Sales (9/12), Producer Price Index (9/12), Industrial Production (9/15), Consumer Price Index (9/16), Durable Goods Orders (9/25), Home Sales (9/26) Gross Domestic Product (9/26) and Chicago Purchasing Managers' Index (9/30).

As of August 28, 2003, the Dow was up approximately 1.0 percent for the month (up 11.8 percent year to date), the NASDAQ was up 3.1 percent for the month (up 33.9 percent year to date) and the S&P500 was up 1.0 percent for the month (13.4 percent year to date.)

### **Sector Review**

**U.S. Treasuries:** The U.S. Treasury yield curve flattened in August as short term rates rose more than long-term rates. With the exception of the long bond, Treasury yields rose higher this month as the sell-off continued. The two-year was yielding 1.97 percent at month-end (up from 1.74 percent at the end of July), the 10-year was yielding 4.46 percent and the 30-year bond was yielding 5.25 percent at the end of August.

In our Treasury portfolios, we have taken advantage of the sell-off by purchasing longer-dated maturities in search of extra yield. We believe it is unlikely that the Fed will tighten interest rates until 2004.

Repurchase Agreements: Overnight repurchase agreements (repo) traded just below the Fed Funds rate of 1.00 percent for most of the month. Repo rates rose mid-month and at month-end when cash traded at a premium. We expect the FOMC to keep the Fed Funds rate at 1 percent when it meets again on September 16.

Commercial Paper: Commercial paper (CP) rates for short (thirty- to ninety-day) paper remained just above Fed Funds at 1.03 percent. Six-month CP cheapened slightly to 1.09 percent, while nine-month paper saw a significant backup to 1.18 percent. Rates are under pressure as the market is pricing in the possibility of a rate hike sometime during the first quarter of 2004. Issuance should begin to increase in the six to nine month area as the economy improves.

In our commercial paper portfolios, we have lengthened slightly to take advantage of the recent back up in yields. We will keep the WAM in the mid-50s until we feel confident a strong economic recovery is on solid ground and the probability of a Fed rate hike increases.

**U.S. Government Agencies:** Rates on agency securities continue to feel pressure due to increased scrutiny on Fannie Mae and Freddie Mac. Agencies continue to trade cheap to commercial paper given the current headline risk.

At the end of August, one-month agency discount notes traded around 1.02 percent, three-month discount notes were yielding 1.06 percent, nine-month 1.22 percent and one-year discount notes were yielding 1.36 percent.
