The Commissioners' Court of Tom Green County, Texas, met in a Special Session September 17th, 2004 in the Edd B. Keyes Building, with the following members present:

Clayton Friend, Commissioner of Precinct #1 Karl Bookter, Commissioner of Precinct #2 Jodie R. Weeks, Commissioner of Precinct #3 Absent Richard Easingwood, Commissioner of Precinct #4 Michael D. Brown, County Judge

County Judge, Michael Brown, called the meeting to order at 8:09 A.M.

Molly Taylor, Elections Administrator reported to the Court that the total amount of votes cast in the Local Option Election pertaining to the Legal Sale of Beer and Wine was 11,328. There were 8,366 voting in favor and 2,962 voting in opposition. Nine votes came in late from overseas that changed the totals to 8,375 in favor and 2,963 in opposition changing the total cast to 11,338. There were 420 ballots sent out that were not returned, but that would not change the outcome of the election.

Judge Brown moved to approve the Canvas of the Local Option Election of September 11th, 2004, to be effective September 19th, 2004, for the Legal Sale of Beer and Wine within the city limits of the incorporated city of San Angelo, Texas. Commissioner Friend seconded the motion and all voted in favor. (Recorded with these minutes)

Judge Brown adjourned the meeting at 8:14 A.M.
