“DISCUSSION AND POSSIBLE ACTION TO ENTER INTO A TAX ABATEMENT AGREEMENT, PURSUANT TO THE COUNTY’S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE, AS REQUESTED BY FORT CONCHO BESS LLC, FOR APPROXIMATELY \$247,000,000 IN IMPROVEMENTS RELATED TO THE STORAGE OF ELECTRICITY USING BATTERIES FOR A TEN YEAR PERIOD AND BEING A 100% TAX ABATEMENT OF AD VALOREM TAXES, WITH PAYMENTS IN LIEU OF TAXES (PILOT PAYMENTS) TO BE MADE ANNUALLY TO TOM GREEN COUNTY AND ANY MATTERS INCIDENT THERETO, AND AUTHORIZING THE COUNTY JUDGE TO SIGN ALL RELEVANT DOCUMENTS. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT COMPRISES APPROXIMATELY 315 ACRES AND IS LOCATED IN SOUTHWEST TOM GREEN COUNTY WITHIN THE TOM GREEN COUNTY FORT CONCHO BESS REINVESTMENT ZONE NUMBER 1.
